FOR FILLIES AND MARES FOUR YEARS OLD AND UPWARD By subscription of \$300 each, which should accompany the nomination or by Supplementary Nomination of \$11,000 each by the closing of entries. \$3,750 to pass the entry box; \$3,750 additional to start, with \$750,000 guaranteed. ANY PREVIOUS KENTUCKY OAKS PARTICIPANT WILL BE GRANTED AN AUTOMATIC BERTH (NO FEES) TO THE 2022 LA TROIENNE PROVIDED THEY ARE NOMINATED BY THE APRIL 16th, CLOSING. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weight: 123 lbs. The maximum number of starters for the La Troienne will be limited to fourteen (14). If more than fourteen (14) entries pass the entry box, the starters will be determined at that time with preference given to graded stakes winners (in order I-II-III), then highest 2021-2022 earnings. Any horse excluded from running because of the aforementioned preference shall be refunded the entry fee and supplementary nomination fee if applicable. Starters to be named through the entry box at the usual time of closing. All supplementary nominations will be required to pay entry and starting fees if they participate. Trophy to winning owner.
