Eligibility Requirements

Criteria:

Funds will be available for workers in the horse racing industry who can demonstrate that they:

- Worked on a part- or full-time basis in the horse racing industry for at least 90 days in the past year; and
- Have had a primary source of income in the horse racing industry for the last year; and
- Have experienced a decrease in needed wages or loss of job on or after March 10, 2020 the result in a lack of resources to pay for essential expenses; and
- Live in the United States or any U.S. territory; and
- Are over the age of legal majority in their in their U.S. state or territory; and
- Meet other requirements demonstrating financial need as determined by the Relief for Equine Industry Needs (“REIN”) Fund.

Employees or board members of the Churchill Downs Incorporated or its subsidiaries **ARE NOT** eligible for grants. Applicants must disclose all relationships to employees or board members of Churchill Downs Incorporate for review by the REIN Fund. All grants are made at the sole discretion of the REIN Fund.

Types of Relief Granted:

Grants are for short-term COVID-19 related hardships in paying any of the following kinds of expenses:

- Home rent or mortgage
- Car payments or transportation costs
- Utility bills
- Student loan payments
- Child care
- Groceries
- Medical bills
